There is no need for you to obtain any further quotes; Make a demand upon your insurer for a breach of your insurance policy (failure to return your vehicle to pre-accident condition, breach of duty of care) and your repairer (negligent repairs resulting in damages, breach of consumer warranties) for the costs to rectify your vehicle along with any other losses (such as hire vehicle). Upon recovery of funds, we will pay the repairer directly for the repair cost; All costs and charges will be paid by the offending party or their insurance company. The repairer will also contribute to these costs and charges. There will be no cost to you except in circumstances where your vehicle is written off, you deal directly with the original repairer (or their insurer) or your insurer about this matter, you withdraw your claim after 14 days of us contacting you to confirm these instructions or decide not to authorise the repairer to repair the vehicle.
